Separate sealed Bids for **Haverford High School** shall be received by Mr. Robert Riegel, Business Manager until 2:00 pm prevailing local time, Thursday, October 15, 2020. Bids shall be received at Haverford Township School District Administration Building, 50 East Eagle Road, Havertown, PA 19083. Bids will be publicly opened and read aloud immediately after specified closing time, at 2:00 pm via digital conferencing software.

Work will be bid as the following Prime Contracts:

Contract No. 1 General Construction

Contract No. 2 HVAC Construction

Contract No. 3 Plumbing Construction

Contract No. 4 Electrical Construction

Bidding Documents will be available September 18, 2020 at 3:00 pm. Bidders are required to secure a complete set of Bidding Documents for all contracts. A complete set of Bidding Documents may be secured only at the offices of KCBA Architects by emailing bids@kcba-architects.com (Phone: (215) 368-5806) in accordance with the Instructions to Bidders. Project information is available at www.kcba-architects.com

A fee of two hundred dollars (\$200), payable to the Architect, is required for one set of Bidding Documents via FTP Server Access. An additional non-refundable twenty-five dollar (\$25 fee) will be required for each set of Bidding Documents on CD in .PDF electronic format, if the documents are to be mailed to the bidder. A separate bank check is required for the additional fee. No additional fee will be required for UPS or Federal Express delivery of documents if Bidder provides a valid account number for delivery service. Documents will not be released until fees are received at the Architect's offices in cash or bank check.

A **non-mandatory pre-bid virtual meeting for all prime contracts, GC, MC, PC, & EC** will be held via digital conferencing service, link provided with drawing receipt.

A **non-mandatory pre-bid walk-thru for all prime contracts** will be held at Haverford High School on Thursday, October 1, 2020. **GC at 8am, MC at 9am, PC at 10am, EC at 11am.** Each contractor is permitted one representative who is to meet at the main entrance for their scheduled time. All contractors are required to wear face masks and observe social distancing for the duration of the walkthrough. Haverford High School is located at 200 Mill Rd, Havertown, PA 19083.

Each Bid must be accompanied by a Certified Check, money order or cashier's good faith check payable to the Order of **School District of Haverford Township** or Bid Bond in an amount not less than 10 percent (10%) of the total bid, as security, Performance and Payment Bonds are required. Each Bid must be accompanied by a Non-Collusion Affidavit in the form set forth in the Bidding Documents.

The right to waive any informality in any Bid, to reject any or all Bids or to award any Contract in the best interest of the Owner is reserved.

Bidders on this Work and all subcontractors shall comply with all provisions of the Pennsylvania Prevailing Wage Act. Bidders on this Work and all subcontractors shall comply with all provisions of the Pennsylvania Commonwealth Procurement Code for Prevention of Environmental Pollution. It is intended to award multiple prime contracts for the work as follows: General Construction, Plumbing Construction, Mechanical Construction, and Electrical Construction.
